### Cancellation and Non-Attendance Policy

Grand Pacific Health is committed to providing excellent health care to our consumers. Our Cancellation and Non-Attendance Policy better enables us to provide high quality services to all consumers accessing our Neurodiversity Assessment Service.

#### **Cancellation Policy**

If you wish to cancel your scheduled appointment, please provide at least 72 hours' notice prior to your appointment time. Providing 72 hours' notice allows us to offer your appointment to another consumer who may need to see a clinician urgently. Except in extenuating circumstances, cancellation or changes to a scheduled appointment within the 72-hour notice period, where we are unable to fill the appointment time, will attract a cancellation fee of \$25 for the initial brief phone consultation or \$100 for the pre-assessment consultation or assessment appointments.

#### **Non-Attendance Policy**

A Non-Attendance is when a consumer does not attend their scheduled appointment on time or shows up more than 15 minutes late. When a consumer does not show for a scheduled appointment, it means that another consumer loses an opportunity to be seen.

Except in extenuating circumstances, non-attendances will be charged a **fee of \$25** for the initial brief consultation or \$100 for the pre-assessment consultation or assessment appointments. After a 3rd non- attendance, you will be charged the total cost of the appointment (at the discretion of management). Once this fee is paid, you will then be able to book further appointments with us.
